

Bloomfield City Council Meeting  
Regular Session  
April 19, 2022 at 6:30pm

Council members present were David Clary, Donna Deardorff, Cecil Haley, Pat Wilson, City Attorney Robin Northern and Mayor Aslin. The mayor called the meeting to order. The meeting was opened with the Pledge of Allegiance followed by a moment of silence.

**Public Comments:** none

**Consent Agenda:** Ald. Deardorff moved and second by Ald. Wilson to approve the consent agenda. Motion passed 4-0 vote.

**Updates:** Allen Walker gave brief update of progress at the lagoon. Sludge removal has been delayed due to all the rain recently. Still waiting for the building over the bar screen. Transfer switch for the generator has arrived.

Community building grant has been signed by the governor. Waiting for DED Director to sign the letter and send via email notification.

Park project grant is waiting for approval, then for the governor's signature.

**BILL #2022-04** AN ORDINANCE AUTHORIZING MAYOR TO EXECUTE A CONTRACT WITH HD QUALITY CONSTRUCTION, LLC. Read one time and a motion was made by Ald. Clary and second by Ald. Deardorff to allow a second read. Motion carried 4-0. Read a second time and Ald. Haley moved to approve Bill #2022-04. Ald. Clary second the motion. Ayes – 4, Nays – 0.

**BILL #2022-05** AN ORDINANCE AMEND THE MUNICIPAL CODE OF THE CITY OF BLOOMFIELD, MISSOURI, BY ADDING NEW SECTIONS WHICH NEW SECTIONS SHALL BE DESIGNATED AS SECTION 205.071 AND 205.072 OF CHAPTER 205 OF TITLE ANIMAL REGULATIONS OF SAID CODE. Read one time and a motion was made by Ald. Wilson and second by Ald. Deardorff to allow a second read. Motion

carried 4-0. Read a second time and Ald. Deardorff moved to approve Bill #2022-05. Ald. Wilson second the motion. Ayes – 4, Nays – 0.

BILL #2022-06 AN ORDINANCE SETTING AN ELECTION ON TUESDAY, NOVEMBER 9, 2022, FOR THE QUALIFIED VOTERS OF THE CITY OF BLOOMFIELD, MISSOURI, TO DECIDE WHETHER TO FOREGO ANNUAL MUNICIPAL ELECTIONS FOR SIX (6) YEARS IF THE NUMBER OF CANDIDATES WHO HAVE FILED FOR EACH OFFICE IS EQUAL TO THE NUMBER OF POSITIONS FOR EACH OFFICE IN ACCORDANCE WITH MO. REV. STAT §115.124. Read one time and a motion was made by Ald. Clary and second by Ald. Haley to allow a second read. Motion carried 4-0. Read a second time and Ald. Haley moved to approve Bill #2022-06. Ald. Deardorff second the motion. Ayes – 4, Nays – 0.
