Bloomfield City Council Meeting Regular Session April 25, 2024 at 6:30pm

Council members present were Pat Wilson, Rachel Clary, Cecil Haley, Donna Deardorff, and City Attorney Robin Northern. The mayor called the meeting to order and lead with the Pledge of Allegiance and moment of silence.

Public Comments: none

<u>Consent Agenda</u>: Ald. Haley moved and second by Ald. Clary to approve the consent agenda. Motion passed 4 - 0 vote.

<u>Updates:</u> DPS/Comm. bldg – it was discovered that the community room needs sound absorbing baffles installed. Justin is to meet with them. A fence is needed between the park and DPS property. Daniel submitted two quotes.

UFO FENCING #1 (steel) \$15,174.24

#2 (aluminum) \$16,590.52

BOOTHEEL FENCE CO. \$24,675.00

Ald. Deardorff moved to accept the bid #1 from UFO FENCING. Ald. Wilson second. Motion passed 4-0.

Park grant – still no word on an award date

Street lights – Donna stated that MoDot is still waiting on the poles for the lights to come in. She also reminded them that the pole beside Café Ghost needs replacing.

Sewer I & I project – CDBG has received notice from DNR. The application is moving forward.

<u>Unfinished Bus</u>: Discussion was had on the options available to the City pertaining to property located at the north end of town.

NEWLY ELECTED OFFICIALS: Newly elected officials Jacob Goodin, Ald. Ward 2 and Nick Roe, Ald. Ward I were sworn in. Mayor Aslin presented outgoing Ald. Ward 2, Pat Wilson, with a plaque for her 17 years of service to the City and Ald. Ward 1, Donna Deardorff, for 18 years of service to the City.

Ald. Clary moved to elect Cecil Haley as Mayor Pro tem and Ald. Goodin seconded the motion. Motion carried 4-0.

Mayor Aslin distributed the list of elected officials to oversee which departments.

It was unanimously agreed by the Mayor and Council to have Donna Deardorff and Pat Wilson removed from all City of Bloomfield's bank accounts as authorized signers and to add Rachel Clary as an authorized signer to all of the City of Bloomfield's bank accounts.

New Bus: Bill #2024.02 AN ORDINANCE ADOPTING AND ENACTING A NEW CODE OF ORDINANCES OF THE CITY OF BLOOMFIELD, COUNTY OF STODDARD, STATE OF MISSOURI; ESTABLISHING THE SAME; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN, EXCEPT AS HEREIN EXPRESSLY PROVIDED; PROVIDING PENALTY FOR THE VIOLATION THEREOF; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE. Ald. Haley moved and Ald. Clary second to allow for a second reading. Motion passed 4-0. Ald. Haley moved and Ald. Clary second to approve Bill #2024.02. Motion passed 4-0.

Ald. Haley moved to accept the certified election results of April 2, 2024. Ald. Clary second. Motion carried 4-0.

Ald. Roe moved to approve the mayor signing a resolution concerning voluntary annexation of property. Ald. Goodin second. All in favor.

Two estimates were received for new windows at City Hall.

H & H SIDING & GUTTERING #1 Single hung \$9792.00

#2 Double hung \$10,574.00

***windows with low-e are \$30 per window = \$540.00

WINDOW WORLD OF CAPE Double hung \$10,884.00

Ald. Roe moved to accept bid #2 from H & H Siding & Guttering with the contingency that adding Low E to the windows would be an additional \$540. Ald. Clary seconded the motion. Motion passed 4-0.

Ald. Haley moved to approve of the mayor signing a proclamation declaring May 5-11, 2024, as Local Government Week. Ald. Roe second. Motion passed unanimously.

<u>Other Matters:</u> Ald. Goodin questioned the decision of the previous council on no parking along J hwy. He would like to discuss this at the May meeting. Ald. Goodin stated he would like to see all city vehicles decaled. Ald. Haley explained that the matter had already been discussed and voted on.
