Bloomfield City Council Meeting Regular Session August 17, 2020 at 6:30pm

Council members present were: Pat Wilson, Frank Sifford and Donna Deardorff. Acknowledging there were enough for a quorum, Mayor Pro Tem Deardoff called the meeting to order. The meeting was opened with the Pledge of Allegiance followed by a moment of silence.
