

Bloomfield City Council Meeting  
Regular Session  
August 22, 2022 at 6:30pm

Council members present were David Clary, Donna Deardorff, Cecil Haley, Pat Wilson, and Mayor Aslin. Robin Northern was absent. The mayor called the meeting to order. The meeting was opened with the Pledge of Allegiance followed by a moment of silence.

**Public Comments:** Eddie Mays, 605 N. Prairie, requested patch work done on Allie Street. Harry Smith, 609 N. Prairie, questioned about some new sidewalks in town. Another request was made for a 4-way stop at the intersection of N. Spring & Hester. Chief Dew will look into this.

**Consent Agenda:** Ald. Deardorff moved and second by Ald. Clary to approve the consent agenda. Motion passed 4-0 vote.

**Updates:** Still waiting on the generator for the lagoon, possibly end of November.

Amy Haas will meet with Katelyn Lambert about the park grant application.

Waiting on the cultural resource study to be performed before moving forward with the CDBG community center grant.

**Unfinished Bus:** Ald. Haley and Ald. Clary moved and second to table discussion of annexing CR 298 & lagoon property until next month's meeting. All in favor.

**New Bus:** Ald. Haley moved and Ald. Clary second to approve the six-month financial statement ending June 30, 2022. All in favor.

**BILL #2022-11 AN ORDINANCE OF THE CITY OF BLOOMFIELD, MISSOURI, ESTABLISHING PROCEDURES AND REQUIREMENTS FOR THE ISSUANCE OF ADMINISTRATIVE SEARCH WARRANTS.** Ald. Deardorff moved with Ald. Wilson second to allow a second read. Motion passed 4-0. Ald. Deardorff moved and Ald. Wilson second to adopt Bill #2022-11. Motion carried.  
Clary – aye, Haley – aye, Deardorff – aye, Wilson – aye.

**BILL #2022-12 AN ORDINANCE ADOPTING AN ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2022 AND APPROPRIATING FUNDS PURSUANT THERETO.**  
Ald. Haley moved with Ald. Clary second to allow a second read. Motion passed 4-0. Ald. Clary moved and Ald. Haley second to adopt Bill #2022-12. Motion carried.  
Clary – aye, Haley – aye, Deardorff – aye, Wilson – aye.

***BILL #2022-13 AN ORDINANCE ESTABLISHING THE TAX RATE FOR THE CITY OF BLOOMFIELD, MISSOURI, FOR 2022 TAXES AND PROVIDING FOR THE EFFECTIVE DATE THEREOF.*** Ald. Deardorff moved with Ald. Wilson second to allow a second read. Motion passed 4-0. Ald. Clary moved and Ald. Deardorff second to adopt Bill #2022-13. Motion carried. Clary – aye, Haley – aye, Deardorff – aye, Wilson – aye.

***BILL #2022-14 AN ORDINANCE TO AUTHORIZE THE MAYOR WITH ANY SUBJECT UNDER CONSIDERATION BY THE BOARD OF ALDERMEN OF SAID CITY TO APPLY FOR FEDERAL FINANCIAL ASSISTANCE ON BEHALF OF THE CITY OF BLOOMFIELD AND THE MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION PROVIDING FOR CAPITAL, OPERATING AND/OR MARKETING ASSISTANCE COMPRISED OF FEDERAL FUNDS TO BE EXPENDED FOR COMMISSION-APPROVED TRANSIT PROJECTS.*** Ald. Clary moved with Ald. Haley second to allow a second read. Motion passed 4-0. Ald. Haley moved and Ald. Clary second to adopt Bill #2022-14. Motion carried. Clary – aye, Haley – aye, Deardorff – aye, Wilson – aye.

**Other Matters:** Kari presented a plan to remodel city hall. All council members will receive hard copies of all the drawings so as to discuss at next month's meeting.

A sidewalk grant application will open toward the end of this year. The City will be making an application.

Ald. Clary moved and Ald. Haley second to approve the purchase of gate panels, for the new dog pound, up to \$4250.00. All in favor.

Ald. Deardorff moved and Ald. Wilson second to allow the purchase of 4 vests, for the DPS officers, for approximately \$4400.00. All in favor. A donation check of \$2845.00 from the Assembly Church will be used to offset this expense.

Next council meeting will be on Monday September 26 at 6:30pm.

Ald. Clary moved to adjourn meeting. Ald. Haley second. All in favor..
