

Bloomfield City Council Meeting
Regular Session
March 28, 2022 at 6:30pm

Council members present were David Clary, Donna Deardorff, Cecil Haley, Pat Wilson, City Attorney Robin Northern and Mayor Aslin. The mayor called the meeting to order. The meeting was opened with the Pledge of Allegiance followed by a moment of silence.

Public Comments: Jim Hall stated that he received his regular water bill on the 11th of this month and was charged a late fee. He stated that he went ahead and paid the bill minus the late fee because it wasn't his fault the bill was late. It was stated that Mr. Hall is not one that is habitually late paying his water bill. Ald. Clary moved to waive Mr. Hall's late fee. Ald. Deardorff second. Motion passed 4-0.

Consent Agenda: Ald. Deardorff moved and second by Ald. Wilson to approve the consent agenda. Motion passed 4-0 vote.

Updates: Allen Walker gave brief update of progress at the lagoon. Sludge removal should begin Thursday or Friday of this week, depending upon the weather. Still waiting on generator delivery, sometime in October.

Community building grant is waiting for the governor's signature.

Park project grant is waiting for approval, then for the governor's signature.

Unfinished Bus: Dogs in the park – Robin will draft an ordinance and present to council for next month's meeting.

New Bus: BILL #2022-02 AN ORDINANCE AMENDING SECTION 155.130 OF CHAPTER 155 OF TITLE PERSONNEL CODE OF THE MUNICIPAL CODE OF THE CITY OF BLOOMFIELD, MISSOURI. Read one time and a motion was made by Ald. Haley and second by Ald. Deardorff to allow a second read. Motion carried 4-0. Read a second time and Ald. Haley moved to approve Bill #2022-02. Ald. Clary second the motion. Ayes – 4, Nays – 0.

BILL #2022-03 AN ORDINANCE PROVIDING FOR THE HOLDING OF AN ELECTION WITHIN AND FOR THE CITY OF BLOOMFIELD, MISSOURI, ON THE QUESTION OF THE APPOINTMENT OF A COLLECTOR AND SETTING THE TIME AT WHICH SAID ORDINANCE SHALL BECOME EFFECTIVE. Read one time and a motion was made by Ald. Clary and second by Ald. Deardorff to allow a second read. Motion carried 4-0. Read a second time and Ald. Clary moved to approve Bill #2022-03. Ald. Wilson second the motion. Ayes – 4, Nays – 0.

Three bids were received for consideration in the construction of a new dog shelter facility.

Ald. Haley moved to accept the low bid from HD Quality Construction. Ald. Clary second the motion. Motion passed 4-0.
