

Bloomfield City Council Meeting  
Regular Session  
June 21, 2022 at 6:30pm

Council members present were David Clary, Donna Deardorff, Cecil Haley, Pat Wilson, City Attorney Robin Northern and Mayor Aslin. The mayor called the meeting to order. The meeting was opened with the Pledge of Allegiance followed by a moment of silence.

**Public Comments:** Amy Haas informed council that the pennants that were purchased last year to hang on the ballfield fence can be renewed for half price. Morgan Wilkinson resigned as Park board president. The park board plans to re-organize at their next meeting.

**Consent Agenda:** Ald. Haley moved and second by Ald. Clary to approve the consent agenda. Motion passed 4-0 vote.

**Updates:** Allen Walker said the lagoon project should be completed by the end of this week. Still waiting on the generator. Mr. Walker requested that the retainage percent be lowered to 2.5%. Ald. Haley moved to lower the retainage percent to 2.5% subject to USDA guidelines and the contract language. Ald. Clary second. Motion carried 4-0.

The city's park grant, for new equipment and upgrades, was denied. Council agreed unanimously to re-apply.

Chief Dew gave council members copies of ordinances from other cities pertaining to nuisance violations. Mayor Aslin requested council to review and will discuss during next month's meeting.

**BILL #2022-08** AN ORDINANCE ADOPTING AND ENACTING A NEW CODE OF ORDINANCES OF THE CITY OF BLOOMFIELD, COUNTY OF STODDARD, STATE OF MISSOURI; ESTABLISHING THE SAME; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN, EXCEPT AS HEREIN EXPRESSLY PROVIDED; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE OF ORDINANCES; PROVIDING PENALTY FOR THE VIOLATION THEREOF; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.

Ald. Haley moved with Ald. Deardorff second to allow a second read. Motion passed 4-0. Ald. Clary moved and Ald. Haley second to adopt Bill #2022-08. Motion carried. Clary – aye, Haley – aye, Deardorff – aye, Wilson – aye.

BILL #2022-09 AN ORDINANCE AUTHORIZING MAYOR TO EXECUTE ALL CONTRACT DOCUMENTS, CHANGE ORDERS, AND ANY AND ALL OTHER NECESSARY INSTRUMENTS AS MAY BE REQUIRED FOR THE CDBG COMMUNITY CENTER GRANT FOR THE CITY OF BLOOMFIELD, MISSOURI.

Ald. Haley moved to allow for a second reading. Ald. Deardorff second. All ayes, no opposed. Ald. Clary moved to adopt Bill #2022-09. Ald. Haley second. Motion passed. Deardorff – aye, Clary – aye, Haley – aye, Wilson – aye.

**Other Matters:** Ald. Haley moved to accept the proposed budget for fiscal year 2023. Ald. Wilson second. Motion passed 4-0.

With nothing further to discuss in open, Ald. Deardorff moved and Ald. Wilson second to enter executive session per 610.021(3). Motion passed 4-0.

Back in regular session.

Ald. Clary moved to reclassify Officer Matney as a full-time officer effective 07/01/2022. Ald. Wilson second. Motion passed 4-0.  
Council approved a suggested reprimand for an officer.

Ald. Clary motioned to approve Weber & Associates creating a new DPS policies and procedures manual for approximately \$3450.00. Ald. Deardorff second. Motion carried 4-0.
