Council members present were: Pat Wilson, Frank Sifford and Donna Deardorff. Bonnie Blue was absent. Acknowledging there were enough for a quorum, Mayor Aslin called the meeting to order. The meeting was opened with the Pledge of Allegiance followed by a moment of silence.

<u>Public Comments</u>: Janice Traughber, Bloomfield Chamber of Commerce Vice President, reviewed upcoming dates and events with the council. Ald. Sifford moved to not having a circus in town on Oct. 14 due to Covid 19, the circus would be inside a tent, and the county's increasing number of active cases. Ald. Deardorf second this. Motion carried 3-0. Council had no objections to the other planned activities since they would not be held in a confined/enclosed area.

Voting for all precincts of Bloomfield will be at Trinity Methodist Church. The City will have an officer posted at the voting site from 6a-7p that day. Will check with County to see if a deputy sheriff can be posted there as well, or alternate shifts with a City officer.

Council agreed to move forward with gathering needed information to move the City's operating account to another bank.

Robin's office sent out 7 collection letters for fire bills.

Justin Bell requested the purchase of a UTV for the use and expense to be split between the water, street, and public safety departments. Justin will check on availability of grants for such purchase and discuss further at the October meeting.
